The Committee reviewed the FY 2011 Priority Setting data sets. For FY 2012 the committee will use the following data sets to inform the EMA's Service Priorities rankings:

# c. Reviewed EIIHA (Early Identification of Individuals with HIV/AIDS—Unaware) strategies review, discussion and action.

## d. Needs Assessment Activity

Discussed the process to conduct an Out of Care (no CD4, Viral Load or Anti-Retroviral Therapy (ART) within the past 6-12 months) Needs Assessment to inform FY 2012 PSRA. Due to partial grant award, timing of Out of Care Needs Assessment will be determined once the Ryan White Office (RWO) receives the full award. MIGHT NOT occur if the EMA receives a cut in funding.
