#### c. Review Planning Council Reflectiveness

The Council is at 35% non-conflicted consumer with a goal of 33%. The Council is still seeking at Medicaid representative as well as Hispanic; Male and non-conflicted consumers. The reflectiveness has become much more compliant with African Americans compliant and males coming closer to compliance. The Council is stills seeking Hispanics, Males and Non-Conflicted consumers (HIV+ individuals who do not work for or sit on the board of a Part A funded agency)
