- **Review the Strategic Planning and Assessment Planning Council Activity Timeline** The Committee reviewed the Planning Council Activity Timeline and determined that everything was on track.

Staff presented the Medical Case Management Health Insurance Survey from last year and the committee reviewed this and made updates to better collect the data that is needed for PSRA:

- 1. CIPA Discussion:
 - Attendees discussed the uninsured number for 'over income/cannot afford private' number of clients these clients should be followed up on and assisted through the CIPA process.
 - Change 'over income for public assistance...' to 'over income for Medicaid (husky)...'
 - Result updated: Uninsured to 'All Insured' and CADAP to read, 'From all uninsured, how many have CADAP?', All ACA Plans, from all ACA plans how many use CIPA, remove 'exchange' from title. Medicare ONLY – 'of those who have Part A and B, how many have Part D?', 'from the clients who have private insurance, how many also have CAPAP?', Private Insurance, Not from ACA (E.G. Employer/spouse paid.
 - A question was asked as to how to remove all duplicates client from the results?
 - Out of this discussion, it was recommended that all MCMs have CIPA training so everyone is consistent in the process and the data they are collecting.
 - It was decided that staff will provide training on CIPA and the MCM Health Insurance Survey during the SPA meeting on January 5, 2017 for medical case managers in our region.
 - This survey will include all clients who received a part A service regardless of what part they are case managed by from
 - The survey will run from March 1, 2017 April 28, 2017 for clients who received any part A service from 2/1/2016 1/31/2017.

Review Framework of PSRA

The committee discussed the process that's been in place for the past 20 years and the possibility that it may be a good time to re-evaluate the entire system and rebuilding it back to be more relevant. Staff also presented the Care Continuum for the EMA from CAREWare including Diagnosed, EIS, and Newly Diagnosed totals from 3/1/15 - 2/29/16. There were 18 EIS Newly Diagnosed and we also looked at the retained to care over a 2-year period, linked to care for a 1-year period, and Virally Suppressed for a 1-year period. We also looked at the Care Continuum that was presented during the PSRA process which represents prevalence not incidents. Heidi will speak with her staff at DPH regarding the 30% of people out of care through 2014. Staff will update the HIV Continuum to reflect the state results vs. EMA results.

- **Review Comprehensive Plan** we are still waiting on the final Statewide Comprehensive Plan, there is currently a draft plan completed. This is due on September 30, 2016.

Directives - What type of evidence do we have or need to prove that the regional funding allocations are working or not working	In process - We discussed this on 8/4 and thought the number of MCM clients would be the number to focus on. A lengthy discussion was heard from all regions represented at the meeting on funding pathways for services received in their region. We will continue to discuss this.
FPL Eligibility for Ryan White Services	In process - Staff has sent this request to Sera Morgan at HRSA and is waiting to hear back.
Undocumented Numbers in CT from DPH	In process– 9/1: Heidi was unable to find anything from DPH to capture this number but there was an estimate. The number of undocumented clients in Part A are 200. The state estimates 3% of our number which would be 180 according to the state. We are at 8% in RW part A. We will continue to discuss this.
