(5.0) New Business/Old Business

- Review the Strategic Planning and Assessment Planning Council Activity Timeline The Committee reviewed the Planning Council Activity Timeline and determined that everything was on track.
- Review implementation of Health Care Reform/National HIV/AIDS Strategy and its impact on RW

Staff presented the updated Medical Case Management Health Insurance Survey that will run from March 1, 2017 – April 30, 2017 for clients who received any part A service from 2/1/2016 – 1/31/2017.

- A request was made to capture the number of unduplicated clients from the MCMs.
- Can the MCMs use the DSS system to ensure that the data collected is accurate? It was determined that all regions will run the reports from the DSS system to capture the information requested from the survey.
- Each region will also capture the number of clients surveyed.
- This process will be discussed during the CIPA training during the SPA meeting in January, 2017.

During this discussion, Nick Boshnack from APNH was called and asked specifically about the New Haven region to see if it is feasible to use the DSS system for a larger region.

Region 5, Waterbury will reach out to Albana in Region 2, Waterbury to assist her with any questions she may have with this process.

• Updates were made real time to the actual survey and will be presented next month.

• Review Framework of PSRA

Staff presented the HIV Care Continuum with the comparison of our EMA vs. Ryan White Part A. This included linked to care, retained in care, prescribed ART and virally suppressed.

• Review Comprehensive Plan

Staff presented the Statewide Comprehensive Plan. We will be concentrating on the Goal section of this and staff will e-mail this plan out to all PC members.

• Determine 2016 Directives to Ryan White Office

Staff presented the current directives to the committee. We began by discussing Directives 1.2, 1.3, 2.1, 2.2, 2.3 and explanations of these were given. Updates were made to change grantee and contractors to Recipient and Sub Recipients. Also Standards of Care were updated to Service Standards. Discussion took place regarding regional representation at Planning Council meetings and how this might fit into this document. We also looked at 1.1 and reviewed the most updated EMA wide data. Several opinions were heard regarding the allocation percentages and the data we use to define these percentages. Suggestions were also heard that we may want to look at population bases in each region. A question was asked, what is a way to measure the need in each region. It was also suggested that we continue to discuss alternative ways to collect data that may be more effective.
