Heidi Jenkins presented a training on the DIS process with the CTDPH. This presentation included potential benefits to providers, data to care goals, continuum of care 2015, CT DPH current data to care activities, process used to determine if someone is in care, proposed data to care model, data sources to identify PLWH who are not in care, ensuring individual privacy and confidentiality and data security and confidentiality and next steps. She also presented Getting to Zero. This presentation included the G2Z Campaign to date, CT's campaign: a data driven process, the commission and the commission's charge. She then presented 'Who are the DIS?'. This included a definition of their roles, project CORECT DI and HIV DIS. Lastly, she presented the HIV Partner Notification Results CY 2016. This included outcomes and demographic data from interviews.
