• Identify Datasets/needs for PSRA and coordinate with other committees to facilitate the exchange of information

Staff presented the spreadsheet that was used during the PSRA process this August in order to determine the information needed for the funded services from each region.

- a. Substance Abuse Inpatient units of service, how are these measured if at all? We will look at this in November
- b. Substance Abuse Outpatient are there any outliers among the regions?
  - a. Question:
    - i. What is each region counting as a unit of service here? Group sessions, individual therapy sessions, intakes, methadone, etc.?
    - ii. Decision: the committee has asked Region 1, 3 4 to re-run their utilization report and include only group and individual sessions.
- c. Mental Health Are we paying Medicaid rates? We will look at this in February
- d. Housing Look at the cost of living among the regions We will look at this in March
- e. Food Bank/Home Delivered Meals are there any outliers among the regions? We will look at this in January

## • Define One New Study and Present Results

Joanne requested that we run our own NA instead of waiting for the state's results from their NA. Other suggestions where we survey the MCMs since they have a great deal of knowledge of what clients are utilizing. Others suggested doing something that we can use to help during the PSRA that is consumer based. Tom suggested focusing on young MSM of color (African American and Hispanic), African American woman and transgender women. We will be doing the following:

- 1. Young MSM of color (African American and Latino) age 29 and below.
- 2. African American Women
- 3. Transgender Women

We will need to get this information from CT DPH to get the entire scope of these populations, EHARS. A data request will need to be sent requesting this information, Sue Speers.
