


(5.0) New Business/Old Business

• Review Intensive Case Management Service Component

Staff presented an overview of this which will fall under the medical case management service category. The 3 priority populations identified in our previous needs assessment will be assessed first as funding for this is coming from MAI dollars. After that case managers will look at newly diagnosed clients, out of care clients and finally, non-virally suppressed and/or medication adherent clients. The committee also reviewed the newly proposed universal intake packets that included 4 documents: medical case management acuity scale template, intake form template, assessment template and care plan template. These forms were reviewed and an adhoc committee will be reviewing these and making any updates/changes needed. We will review these again in April.

Staff has sent an email out to all regions with the survey attached and a start date of March 1st.




