John Sapero gave the following report: Since meeting with focus groups, he has collected the following information:

- a. 347 individual ideas have been shared
- b. 65 strategies have been identified (community outreach and such)
- c. The strategies have been organized into 25 themes
- d. Most discussed themes revolve around HIV Testing, Education, Access to Care, Innovation and Systems Improvement.


• Develop and Review the Comprehensive Plan


