
Review the Strategic Planning and Assessment Planning Council Activity Timeline
 The Committee reviewed the Planning Council Activity Timeline and determined that everything was on track.


# • Define One New Study and Present Results

Jeff Daniel reported on a meeting he had with the Legislative Liaison in the Mayor's Office (Kevin Alvarez) on May 5, 2021. He shared the presentation that he presented to Kevin. The Mayor's Office wanted to understand the difference in FPL compared to other funding sources. After a lengthy discussion with the Recipient, Tom Butcher, the committee decided that at this time, there will be no change to our FPL eligibility for Part A.

Guidance should be coming out next month that will direct in this plan.


