Summary of Council Business Votes

Minutes of October 9, 2009 Planning Council meeting

(1.0) Moment of Silence

Leif Mitchell called the meeting to order at 12:00 p.m. A moment of silence was observed in recognition of all who have been affected by HIV/AIDS.

(2.0) Welcome And Introduction

Leif Mitchell asked participants to introduce themselves and reminded attendees that the meeting public and open to the press. Participants are asked to use good judgment in disclosing any personal information during introductions.

(3.0) Co-Chair Announcements & Meeting Objectives

Leif Mitchell discussed the issue with Service Definitions prior to the December meeting. Tom Butcher was called and clarified that at the conference call next week (November 18th) that in addition to Latrece Timmons, the Project officer, Karen Mercer-Brown (Eastern Bureau Branch Chief) is scheduled to be present. The two items in question will be discussed and resolved. These two items are the Medical Transportation issue (can PLWHA use transportation for Ryan White entities in addition to Part A) and ADAP/Local (the historic definition was correct with New Haven-Fairfield Counties EMA 'catching' an incorrectly released version by HRSA. The 'zeroing out' of this line was not needed.

In addition, discussion occurred regarding the newly reauthorized Ryan White HIV/AIDS Treatment Modernization Act bill. Sentiments about providing education and information to the Planning Council were voiced, with discussion about whether to provide the Side by Side review (current to newly reauthorized legislation) and/or President Obama's comments when he signed the bill. It was concluded that this information will be distributed in December since preparation for the questions related to this information will need to occur, and lengthy discourse could follow such distribution.

(4.0) Public Comment

Leif Mitchell informed the group that the Planning Council, in addition to allowing the Public to comment about any matters of importance to them, will start, at this meeting, to 'prompt' the group by posing a question of concern to the planning body. This month's question related to Planning Council membership—how to entice new members, particularly consumers, to join and how to retain their involvement. Of particular interest due to reflectiveness of the epidemic in the EMA, are Hispanic, male and non-aligned consumers (those consumers not working at an agency contracted by Ryan White Part A). Ideas forwarded were:

- (1) Time of meeting those PLWHA that work find a mid-day meeting inconvenient, and have to balance taking unpaid time off work against involvement. Consideration of an evening meeting?
- (2) What is involved in being a member? Response: actively attend a sub-committee meeting (Membership/Finance, Strategic Planning & Assessment, Quality Improvement held the week before this meeting and regularly attend Planning Council meetings, read materials and interface

- (3) Get the word out by talking to groups including client groups at provider agencies within the EMA
- (4) Consider transportation and possible stipend for members attending meetings
- (5) Question: Can you keep your Case Manager once on the Committee? Response: YES—not related.

Other Public Comment:

Dennis Torres informed the group that there is an Office of National AIDS Policy (ONAP) consumer forum to be held on Friday, December 4th in New York City.

These three primary goals for the NHAS are:

- 1) Reducing HIV incidence
- 2) Increasing access to care and optimizing health outcomes
- 3) Reducing HIV-related health disparities

Review Council Reflectiveness

Review of the Planning Council Composition as of November 5, 2009 showed that membership is non-reflective for Males (7 or 44% vs. target of 12 or 65%), Hispanics (2 or 11% vs. target of 5 or 29%) and non-conflicted consumers (3 or 17% vs. target of 6 or 33%).

Discussion about (1) Transportation being arranged for new or prospective consumer members and (2) whether a stipend can be paid to consumer representatives that are non-conflicted.

The issue of Hispanic membership was discussed in light on issues with non-reflectiveness. Study will occur about the need (and cost) in translating agendas, minutes and having an interpreter. Consideration of use of bilingual members to mentor monolingual applicants occurred, as did the prospect of translating the Planning Council Membership brochure into Spanish.
