Meeting Summary/Minutes

Welcome, Overview and Moment of Silence

Ric Browne welcomed meeting participants, asked everyone to introduce themselves, and held a moment of silence to honor individuals affected, infected, or who have died from HIV/AIDS.

Ric Browne reminded people that the meetings are open and members of the public and press may be present. Persons wishing to maintain confidentiality of their HIV status should consider the public nature of the meeting.

Approval of Meeting Summary

Ric Browne asked meeting participants to review the February 6th meeting summary and asked committee members for additions or corrections.

Ryan White Office Quality Management Report

Tom Butcher reported that HRSA requested submission of a Comprehensive, 3-year Quality Management Plan by December 4th. This document includes the Annual Quality Improvement Committee plan, and was submitted on November 24th to the Project Officer

Super Pod Findings (from December 2008 to May 2009):

1) Using a collaborative, topic-based discussion, an average of 18 providers, consumers and staff refined and updated Service <u>Use</u> Definitions for each funded service category, Outcomes and Indicators, and discussed use of tools and evidence-based measures.

2) Over the course of nine (9) meetings at which all regions were represented, with attendance of an average of 7 QIC members at each session, the following agenda items were reviewed:

- a. Update Service Use Definition, Outcome & Indicator by Service Category
- b. Discuss Behavioral Health (Mental Health/Substance Abuse) in detail
- c. Discuss Clinical (Primary Medical Care/ Medical Case Management) in detail
- d. Review System Level Issues"
- e. Finalize (Revise, Develop) Standards of Care and Review QI 'Architecture':
 - 1. Administrative 2. System Level 3. Service (a. Clinical b. Support)

Re-convening of Super-Pod based on Full Population based Chart Audit (June-August, 2009):

1) Update of Service USE Definitions, Indicators, Outcomes

- i. Questionable Outcomes or Indicators highlighted for review, discussion
 - Food: delete HRSA provided outcome of "reduced need for food based on provision"
 Outpatient/Ambulatory Medical Care: refine co-infection outcome to be quantifiable (HIV: Hepatitis C)
- ii. Discussion of need for Early Intervention Service (EIS) Standard of Care

i. DMHAS comparison

1) Comparison of DMHAS Behavioral Health Levels of Care, Council on Accreditation (COA) occurred for Mental Health. Detailed matrices of comparison to the current Standards for Mental Health, Substance Abuse Outpatient and Inpatient services will occur.

ii. Other EMA/TGA comparison

2) Comparison of other EMA and TGA's Behavioral Health Standards were requested.

iii. Standard of Care by modality

3) Extensive discussion occurred about 'Community Access' models with discussion of the need for each (or many) agencies to have embedded mental health and/or substance abuse professionals versus regional capacity.

A triangle of HIV primary medical care, mental health and substance abuse was discussed with these three disciplines coordinating their activities through defined roles.

A continuum of care for mental health was reviewed, with ability to assess and re-assess client need using defined tools (evidence-based instruments), then position the client quickly at the appropriate level of care.

New and Old Business

Ric Browne asked the committee members if there were any additional items they would like to raise. No items were referenced.
