a. Review Planning Council Feedback

b. Review SPA PCAT

Joann reviewed the PCAT and PSRPP in detail with the committee, including actions and timing. There was no discussion. The group decided to have two four hour sessions for PSRPP, rather than to try and do it all in one day.

c. EIIHA (Early Identification of Individuals with HIV/AIDS—Unaware) strategies review, discussion and action

The committee discussed the survey planned for EIIHA. This required considerable time, as the group tried to keep the questions to no more than 15, and to insure the wording was adequate without being offensive. They agreed to use the region/state approved wording that Leif suggested, and cover these topics:

- 1) Zip Code or City, even for Homeless
- 2) Gender
- 3) Race
- 4) Ethnicity
- 5) Age
- 6) Last Primary Doctor visit
- 7) Reason for Doctor visit
- 8) Ever tested for STDs; results
- 9) Ever tested for Hepatitis; results
