The PCAT was reviewed and the committee is on target with its goals.

#### (5.c.) Determine Allocations for FY11 grant Application

The committee began reviewing data sets for determining resource allocations for the priorities identified during the last SPA committee. The committee began looking at the data for:

- 1. PLWHA currently in care
- 2. PLWHA that are newly diagnosed/returning to care that will enter the Ryan White Part A program (based on Epidemiological data)
- 3. Out of Care Individuals we want to bring into care (based on the EMA's Unmet Need Framework/Estimate)
- 4. Unaware individuals who don't' know their HIV status: identifying them, testing them and linking them to appropriate medical care (most likely this will occur through the Early Intervention Services service category).

Additional data sets such as the Medicaid data will not be available until August 12<sup>th</sup>. The committee decided to complete the resource allocation process during a special meeting and will include information that was not available today by that date.

The special meeting will be held on Thursday, August 19<sup>th</sup> from 9-11 am at Burroughs Community Center.
