#### (5.0) New/Old Business

#### (5.a.) Review PC Feedback from September Meeting

The committee reviewed the feedback from the September Planning Council meeting. There were no significant findings.

#### (5.b.) Review SPA Planning Council Activity Timeline (PCAT)

The PCAT was reviewed and the committee is on target with its goals. The review of the HRSA service category definitions has already been completed and the committee will continue to review unaware strategies and PC feedback today.

#### (5.c.) FY 2011 Directives to the Ryan White Office

The committee continued reviewing and finalized the directives for 2011. The committee developed the new directive for Early Intervention Services (EIS). Extensive discussions were held by the committee on how this service category would be deployed and discussed the following points of the unaware specialist's role under EIS such as:

- o How it will affect existing Outreach workers/programs
- o Should the position be located where the disease is highest vs. each region
- o Availability to each region and
- o Whether they will be part of a multi disciplinary team and addressing:
  - health literacy
  - counseling and testing
  - access and linkage to care
  - referral service

After this discussion the committee decided that the specifics of the role of an unaware specialist will be defined by the Ryan White Office over the next couple of months and reported back to the committee. The finalized directives will be forwarded to the Ryan White Office and the final copy of the directives will be posted onto the website once approved.

# (5.d) EIIHA (Early Identification of Individuals with HIV/AIDS-Unaware) strategies, review, discussion and action

The 2011 Part A grant application prompted today's discussion of EIIHA and strategies on how the EMA will be focusing in 2011 to reach these populations and address the new EIIHA initiative. The committee discussed and reviewed how to identify strategies to reach out to subpopulations in the EMA, such as MSM's; IDU; Aged and the types of activities that may be necessary to engage these subpopulations to be tested, access care/services.

  - Where to find these people
    - Ex: Bath houses, senior centers, bars
